**AWARD OF CONTRACT – JACK DOHNEY COMPANIES THROUGH  
NATIONAL JOINT POWERS ALLIANCE  
ONE (1) TANDEM AXLE RAMJET SEWER CLEANER**

**WHEREAS**, the Township of Warren has the need for an Tandem Axle Ramjet Sewer Cleaner for use by the Department of Public Works; and

**WHEREAS**, the Township of Warren is authorized pursuant to N.J.S.A. 52:34-6.2 (b) (3) to use alternative procurement methods by entering into nationally recognized cooperative contracts; and

**WHEREAS**, the Township has compared pricing for comparable goods from other vendors and has determined that the use of a cooperative purchasing agreement shall result in cost savings to the Township; and

**WHEREAS**, the Warren Township Public Works Superintendent and the Township Administrator have recommended that the Township purchase one (1) Tandem Axle Ramjet Sewer Cleaner from Jack Doheny Companies, 777 Doheny Drive – P.O. Box 609, Northville, MI, 48167, through a national cooperative purchasing agreement with National Joint Powers Alliance (“NJPA”), subject to certain terms and conditions.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey, as follows:

1. The Township Committee shall purchase from Jack Doheny Companies., one (1) Tandem Axle Ramjet Sewer Cleaner in the total amount of \$57,000.00 as set forth in the Quote from Jack Doheny Companies, dated October 17, 2017.

2. The purchase is made pursuant to a national cooperative purchasing agreement with NJPA, Contract #022014-FSC.


3. A Notice of Intent to award this Contract shall be advertised in the official newspaper of the Township.


