**AUTHORIZING PURCHASE OF #2 ULTRA LOW SULFUR DIESEL FUEL THROUGH  
MORRIS COUNTY COOPERATIVE PURCHASING AGREEMENT**

**WHEREAS**, the Township Committee of the Township of Warren by Resolution No. 2016-140, adopted on June 9, 2016, entered into an agreement to renew membership with the Morris County Cooperative Pricing Council through September 30, 2021; and

**WHEREAS**, the Morris County Cooperative Pricing Council received bids for motor gasoline, and awarded said Contract #12: #2 Ultra Low Sulfur Diesel Fuel; and

**WHEREAS**, Warren Township requires the purchase of this item; and

**WHEREAS**, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and is made a part hereof indicating that the maximum for the within expenditure is charged to the following account #'s Fuel Trust 9-03-286-56-2516 and Diesel 9-01-31-447-7002; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Warren, that the Purchasing Agent is hereby authorized to purchase the items below in accordance with the Cooperative Purchasing Agreement as described above.

The price per gallon shall be the posted Newark tank car price at the time of delivery plus delivery charge.


