

**TOWNSHIP OF WARREN
RESOLUTION NO. 2019-109
AUTHORIZING 2nd EXTENSION OF CONTRACT - ASSESSOR SERVICES LLC
FOR TAX ASSESSMENT SERVICES**

WHEREAS, the Township Committee adopted Resolution 2017-167 on June 15, 2017, and Resolution 2018-89 on awarding a contract to Assessor Services, LLC, 414 Runyon Court, Flemington, NJ 08822, in the amount of \$26.50 for residential inspections fee per inspection and \$26.50 for added assessment inspection fee per or a maximum amount not to exceed \$40,000.

WHEREAS, Assessor Services, LLC, will perform special tax assessment services for the Township of Warren for the inspection and real property reassessment and assessments in the Township.

WHEREAS, the contract heretofore approved provides that the Township may extend said contract for two (2) additional one (1) year terms subject to review and approval of the Township Committee by Resolution; and

WHEREAS, the Township Administrator has recommended that the contract be extended for an additional one (1) year period 6/30/2019-7/1/2020; and

WHEREAS, a certification showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and made a part hereof indicating that the maximum appropriation for the within expenditure is charged to account # 9-01-20-150-6111; and

NOW THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Warren, hereby authorizes the extension of the contract with Assessor Services, LLC, 414 Runyon Court, Flemington, NJ 08822, in the amount of \$26.50 for residential inspections fee per inspection and \$26.50 for added assessment inspection fee per or a maximum amount not to exceed \$40,000.
