WHEREAS, Warren Township requires this service and hereby extends the contract until June 31, 2020; and

WHEREAS, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and is made a part hereof indicating that the appropriation for the within expenditure is charged to account # 9-01-26-310-6102 and various other accounts pursuant to the project, with a maximum not to exceed \$75,000 unless approved by the Township Committee, for a period of July 1, 2019 – June 31, 2020.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Warren, that Magic Touch Construction Co., Inc. and Redmann Electric Co., Inc. be awarded the bid Electrical Services as indicated in bid submitted; and
