**WHEREAS**, said Director may also approve the insertion of any item of appropriation for equal amount; and

**WHEREAS**, the Township of Warren has received funding pursuant to check # 2099 dated April 17, 2018, from the Garden State Municipal Joint Insurance Fund in the sum of \$1000.00; and

**NOW, THEREFORE BE IT RESOLVED** that the Township of Warren, in the County of Somerset, hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the budget of the year 2018 in the sum of \$1000.00 pursuant to a grant received from the Garden State Municipal Joint Insurance Fund; and


