

**TOWNSHIP OF WARREN
RESOLUTION NO. 2018-115**

**AWARD OF CONTRACT – POWERCO INC.
ONE KUBOTA – THROUGH
NATIONAL JOINT POWER ALLIANCE**

WHEREAS, the Township of Warren has the need for a Kubota for use by the Department of Public Works; and

WHEREAS, the Township of Warren is authorized pursuant to N.J.S.A. 52:34-6.2 (b) (3) to use alternative procurement methods by entering into nationally recognized cooperative contracts; and

WHEREAS, the Township has compared pricing for comparable goods from other vendors and has determined that the use of a cooperative purchasing agreement shall result in cost savings to the Township; and

WHEREAS, the Warren Township Public Works Superintendent and the Township Administrator have recommended that the Township purchase one Kubota S Series SVL75-2HFWC with related equipment from Powerco Inc., 12 Route 173, PO Box 4995, Clinton, NJ 08809, through a national cooperative purchasing agreement with National Joint Powers Alliance (“NJPA”), subject to certain terms and conditions.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey, as follows:

1. The Township Committee shall purchase from Powerco Inc., one Kubota S Series SVL75-2HFWC in the amount of \$66,421.80 pending the completion of the legal publication requirements.

2. The purchase is made pursuant to a national cooperative purchasing agreement with NJPA, Contract number 042815-KBA.


3. A Notice of Intent to award this Contract shall be advertised in the official newspaper of the Township.

A Certificate showing the availability of funds for the Contract authorized hereby is provided by the Chief Financial Officer and is made a part hereof, indicating that the appropriation for the within expenditure is charged to the following account # X-04-55-877-6001 in the amount of \$65,000 and 8-01-26-315-6517 in the amount of \$1,421.80.


