NOW, THEREFORE, BE IT RESOLVED that the Township of Warren, in the County of Somerset, hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the budget of the year 2018 in the sum of \$3,588.39 pursuant to a grant received from the State of New Jersey providing funding for 2018 Alcohol Education Rehab Fund;

BE IT FURTHER RESOLVED that a like sum of \$3,588.39 is hereby appropriated under the title Public and Private Programs Offset by Revenue, 2018 Alcohol Education Rehab Fund;

BE IT FURTHER RESOLVED that the Township Clerk and Chief Financial Officer are authorized to execute and forward to the Director of the Division of Local Government Services the appropriate documentation required for the Director's approval.
