**APPROVAL OF THE INSERTION OF A SPECIAL ITEM OF REVENUE IN THE
BUDGET RECEIVED FROM NEW JERSEY STATE POLICE**

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any item of appropriation for equal amount; and

WHEREAS, the Warren Township has received funding from the New Jersey State Police, National Crime Statistics Exchange Police Grant in the sum of \$43,500.00; and

NOW, THEREFORE BE IT RESOLVED that the Township of Warren, in the County of Somerset, hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the budget of the year 2018 in the sum of \$43,500.00 pursuant to a grant received from the New Jersey State Police; and

BE IT FURTHER RESOLVED that a like sum of \$43,500.00 is hereby appropriated under the title NJSP-National Crime Statistics Exchange Police grant;

BE IT FURTHER RESOLVED that the Township Clerk and Chief Financial Officer are authorized to execute and forward to the Director of the Division of Local Government Services, the appropriate documentation required for the Director's approval.




