 DOCK WATCH HOLLOW BRIDGE REPAIR

WHEREAS, Warren Township has a need to acquire services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, The Township Administrator has determined that the value of the acquisition will exceed the pay to play threshold of \$17,500 and therefore requires action by the Township Committee, which is hereby authorized; and

WHEREAS, the Purchasing Department acquired quotes for the Dock Watch Hollow bridge repair; and

WHEREAS, the Township Administrator and Superintendent of Public Works are recommending that Carroccia Company, Inc., 336 Route 22, Green Brook, NJ be awarded this contract which shall not exceed \$18,500.00; and

WHEREAS, a certificate showing the availability of funds is hereby provided by the Chief Financial Officer, and is made a part hereof indicating that the maximum for the within expenditure is charged to account number 2-01-26-290-6524..

NOW, THEREFORE, BE IT RESOLVED, that Carroccia Company, Inc. has completed and submitted a Business Entity Disclosure Certification which certifies that Carroccia Company, Inc. has not made any reportable contributions to a political or candidate committee in Warren Township in the previous one year, and that Carroccia Company, Inc., is prohibited from making any reportable contributions through the term of the contract.

BE IT FURTHER RESOLVED, that the appropriate Township officials are authorized to execute the necessary contracts and purchase orders.
