

**TOWNSHIP OF WARREN
RESOLUTION NO. 2022-273
AWARD OF CONTRACT – FURNISHING EQUIPMENT AND PERSONNEL
FOR SNOW PLOWING TOWNSHIP ROADS**

WHEREAS, bids for Furnishing Equipment and Personnel for Snow Plowing were advertised in the October 11, 2022 edition of the Courier News and received on November 1, 2022 at 10:00 a.m.; and

WHEREAS, the following three (3) bids were received:

SE Rose Trucking & Excavating, Inc.	\$174.00 Per Hour Per Truck
Frank Galbraith & Son	\$185.00 Per Hour Per Truck
Messercola Excavating, Co., Inc.	\$250.00 Per Hour Per Truck

WHEREAS, the Township Attorney has reviewed the bids and finds that the lowest bid is responsive and meets the legal requirements; and

WHEREAS, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and is made a part hereof indicating that the appropriation for the within expenditure is charged to account # 2-01-26-290-6526 (Roads 2022 Snow Removal) and account # 3-01-26-290-6526 (Roads 2023 Snow Removal - to be encumbered after the adoption of the 2023 Temp and Final Budget)

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Warren, that SE Rose Trucking & Excavating, Inc. be awarded the bid for Furnishing Equipment and Personnel for Snow Plowing Township Roads as indicated in the bid submitted, in the amount of \$75,000.00, subject to the contractor providing his State of NJ Employee Information Report

BE IT FURTHER RESOLVED, that the appropriate Township officials are authorized to execute the necessary contracts and purchase orders.
