

**TOWNSHIP OF WARREN  
ORDINANCE NO. 10-10**

**AN ORDINANCE AUTHORIZING THE AMOUNT OF \$330,000 AS AN APPROPRIATION FROM CAPITAL IMPROVEMENT FUND AND AN APPROPRIATION FROM CAPITAL FUND BALANCE TO PROVIDE FOR THE OVERLAY OF VARIOUS ROADS IN WARREN TOWNSHIP**

**BE IT ORDAINED** by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

**WHEREAS** the Superintendent of Public Works has recommended the overlay of certain streets in Warren Township, said streets to include but are not limited to:

William Penn Road westbound to 31 William Penn Road  
Wells Lane  
Rockage Road  
Valley View to Old Smalleytown Road  
Round Top Road from Mountainview Road to Orchard Way  
Ferguson Road from Dock Watch Hollow Rd eastbound to the 2nd bridge  
Maple Ave

**WHEREAS**, the Township Committee has agreed to said recommendation;  
and

**WHEREAS**, it is necessary that steps be taken to provide for the establishment of the necessary financial authorization in accordance with New Jersey financial procedures to implement this project; and

**WHEREAS**, funds are available in the Capital Improvement Fund Account No. 03-000-3200 and Capital Fund Balance Account No. 03-000-3800 to provide for this project; and

**WHEREAS**, funds are also available for this project in the 2009 Reserve Budget Roads OE in the amount of \$85,000; and

**WHEREAS**, the total funds to be appropriate by this ordinance and from the 2009 reserve budget is \$415,000;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey as follows:

Section 1) The capital improvement herein described below is hereby authorized as a capital improvement to be made by the Township of Warren,

County of Somerset, New Jersey and for the said improvement there is hereby authorized the sum of \$330,000.

Section 2) The purpose of this appropriation is for the purchase for the overlay of various streets in Warren Township pursuant to the list contained in this ordinance or as may be modified by resolution of the Township Committee based upon the recommendation of the Superintendent of Public Works as necessary in order to insure compliance available appropriation.

Section 3) There is hereby authorized an appropriation from the Capital Improvement Fund Account No. 03-000-3200 in the amount of \$234,000 and from Capital Fund Balance Account No. in the amount of \$96,000. The Township Chief Financial Officer shall, prior to the effective date of this ordinance, file with the Township Clerk a statement certifying that sufficient funds are available in the in Capital Fund Balance and/or the Capital Improvement Fund to make the said appropriation. The original certification shall be attached to the original of the ordinance and shall be kept in the files of the Township Clerk.

Section 4) The Capital Budget of the Municipality is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith.


Section 5) Any further action regarding this project may be effectuated by resolution of the Township Committee.

Section 6) If any section or provision hereof shall be adjudged invalid, such determination shall not affect any other provisions hereof, which shall remain in full force and effect.

Section 7) This Ordinance shall be effective upon final adoption and publication thereof in accordance with law.
