

**TOWNSHIP OF WARREN
ORDINANCE NO. 16-05**

AN ORDINANCE AUTHORIZING THE AMOUNT OF \$70,000 AS AN APPROPRIATION FROM THE CAPITAL IMPROVEMENT FUND TO PROVIDE FUNDING FOR THE PURCHASE OF A COMPACT EXCAVATOR WITH HYDRAULIC THUMB AND RELATED EQUIPMENT FOR USE BY THE PUBLIC WORKS DEPARTMENT

BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

WHEREAS, the Superintendent of Public Works has requested the purchase of a compact excavator with hydraulic thumb which is a multifaceted piece of equipment which can be utilized for drainage projects, cleaning of streams, and demolition of a variety of projects; and

WHEREAS, the Township has been spending township dollars renting this equipment in recent years and purchasing said equipment at this time is appropriate; and

WHEREAS, the Township Administrator has recommended the purchase of said equipment and the Township Committee has reviewed the recommendation; and

WHEREAS, funds are available in the Capital Improvement Fund Account No. 6-04-225-55-3200 to provide for this purchase;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey as follows:

Section 1) The Capital Improvement herein described below is hereby authorized as a Capital Improvement to be made by the Township of Warren, County of Somerset, New Jersey and for the said improvement there is hereby authorized the sum of \$70,000.

Section 2) The purpose of this appropriation is for the purchase of a compact excavator with hydraulic thumb and related equipment.

Section 3) There is hereby authorized an appropriation from the Capital Improvement Fund Account No. 6-04-225-55-3200 in the amount of \$70,000. The Township Acting Chief Financial Officer shall, prior to the effective date of this ordinance, certify that sufficient funds are available in the Capital Improvement Fund to make the said appropriation. The certification is incorporated within the ordinance.

Section 4) The Capital Budget of the Municipality is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith.

Section 5) Any further action regarding this project may be effectuated by resolution of the Township Committee.


Section 6) If any section or provision hereof shall be adjudged invalid, such determination shall not affect any other provisions hereof, which shall remain in full force and effect.

Section 7) This Ordinance shall be effective upon final adoption and publication thereof in accordance with law.


