

**TOWNSHIP OF WARREN
ORDINANCE NO. 15-08**

AN ORDINANCE AUTHORIZING THE AMOUNT OF \$40,000 AS AN APPROPRIATION FROM THE CAPITAL FUND BALANCE TO PROVIDE FUNDING FOR THE PURCHASE OF A FOUR WHEEL DRIVE UTILITY VEHICLE FOR USE BY THE WARREN TOWNSHIP VOLUNTEER FIRE DEPARTMENT FIRE POLICE

BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

WHEREAS, the Fire Chief has requested a 4 wheel drive utility vehicle to be assigned to the Fire Police in order to transport members and equipment; and

WHEREAS, the vehicle will replace an ambulance donated for use by the Fire Police by the Warren Township Rescue Squad and said vehicle is no longer reliable; and

WHEREAS, the Township Administrator has recommended this purchase; and

WHEREAS, funds are available in the Capital Fund Balance Account No. 5-04-400-65-3800 to provide for this purchase;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey as follows:

Section 1) The capital improvement herein described below is hereby authorized as a capital improvement to be made by the Township of Warren, County of Somerset, New Jersey and for the said improvement there is hereby authorized the sum of \$ 40,000.

Section 2) The purpose of this appropriation is for the purchase of a four wheel drive utility vehicle for use by the Warren Township Volunteer Fire Department Fire Police.

Section 3) There is hereby authorized an appropriation from the Capital Fund Balance Account No. 5-04-400-65-3800 in the amount of \$40,000. The Township Chief Financial Officer shall, prior to the effective date of this ordinance, file with the Township Clerk a statement certifying that sufficient funds are available in the Capital Improvement Fund to make the said appropriation. The original certification shall be attached to the original of the ordinance and shall be kept in the files of the Township Clerk.

Section 4) The Capital Budget of the Municipality is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith.


Section 5) Any further action regarding this project may be effectuated by resolution of the Township Committee.

Section 6) If any section or provision hereof shall be adjudged invalid, such determination shall not affect any other provisions hereof, which shall remain in full force and effect.

Section 7) This Ordinance shall be effective upon final adoption and publication thereof in accordance with law.
