## TAX /SEWER PAYMENT OPTIONS

The Warren Township Department of Tax Collections is responsible for processing billing and payments for property taxes and sewer.

Property tax bills are mailed in July with a due date of  
August 1st / November 1st / February 1st / May 1st  
Sewer bills are mailed in January with a due date of February 1st and August 1st  
We offer a 10-Day grace period for tax and sewer payments

### **ACH DIRECT WITHDRAWAL:**

You are able to pay your property tax and /or sewer bill using ACH Direct Withdrawal. The ACH service is **FREE** of charge. Complete and mail the form on the other side of this page by the 15th day of the month before payment is due. Please note if you wish to have both your taxes and sewer paid using the ACH you will need to complete **two separate forms**. You only need to submit this application once and the payments will be deducted on every subsequent due date.

### **MAKE PAYMENT ONLINE:**

- 1) Go to <http://warrennj.org> and scroll down to **Warren Gateway** which is located on the bottom on the left hand side. Click on this and select "**Pay Your Taxes and Sewer Bill Online**"
- 2) Find your home through one of the searches, then click "**Make Payment**"
- 3) Follow payment instructions:
  - \*If paying by Electronic Check there is no cost
  - \* If paying by Debit/Credit Cards the fee will be approximately 2.55% of your total bill

### **MAKE PAYMENT IN PERSON:**
