

Explanation: This Ordinance amends Chapter II of the Township Code entitled, "Administration" by reducing the fees for the use of the Township's synthetic turf fields from \$200 to \$100.

ORDINANCE NO. 12-03**

AN ORDINANCE AMENDING FEES CHAPTER II, FUND RAISING; SERVICE CHARGES AND FEES FOR USE OF RECREATIONAL FACILITIES

BE IT ORDAINED, by the Township Committee of the Township of Warren, County of Somerset, State of New Jersey that Chapter II of the Township Code entitled, "Administration" is hereby amended as follows:

SECTION I. Section 2-20 entitled, "Board of Recreation Commissioners" is hereby amended by amending the fees in subsection 2-20.4(b) entitled, "Fund Raising; Service Charges and Fees for Use of Recreational Facilities" by reducing fees for the use of the Township's synthetic turf fields from \$200 to \$100. The remainder of subsection 2-20.4 (b) shall remain unchanged. The new section shall read as follows:

2-20 Board of Recreation Commissioners.

2-20.4 Fund Raising; Service Charges and Fees for Use of Recreational Facilities.

b. Fees for Use of Recreational Facilities. All applicants seeking the use of the Township of Warren's pavilion and athletic fields (grass and synthetic turf) must complete a department of recreation facility use application and pay the fee prescribed by the following table:

(Synthetic Turf Fields)

Nonprofit entities under 66% residents and in-town for profit entities ***(**)**

\$100 (3 hrs)

Nonresidents and out-of-town for profit entities

[\$200] \$100 (1 hr)

Refund Processing Fee

\$20 per transaction

SECTION II. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.


SECTION III In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township of Warren, the provisions hereof shall be determined to govern. All other parts, portions and provisions of *The Revised General Ordinances of the Township of Warren* are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION IV. This Ordinance shall take effect immediately upon final passage and publication according to law.
