

**EXPLANATION:** This Ordinance amends Chapter II entitled "Administration" of the Revised General Ordinances of the Township of Warren by increasing the number of Lieutenants in the Police Department from two (2) to three (3).

**TOWNSHIP OF WARREN  
ORDINANCE NO. 13-22**

AN ORDINANCE AMENDING CHAPTER II ENTITLED "ADMINISTRATION" OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WARREN BY INCREASING THE NUMBER OF LIEUTENANTS IN THE POLICE DEPARTMENT.

**BE IT ORDAINED**, by the Township Committee of the Township of Warren, County of Somerset, State of New Jersey that Chapter II of the Revised General Ordinances of the Township of Warren entitled "Administration" is hereby amended as follows:

**SECTION I.** Section 2-3 entitled "Police Department" is hereby supplemented and amended by amending Subclause (a) of Subsection 2-3.1 entitled "Establishment and Organization" to read as follows:

- (a) The Township of Warren Police Department, as has been heretofore legally established under applicable laws of the State of New Jersey, is continued. The police department shall consist of no more than a chief of police, [one captain,]\* [two] three lieutenants, six sergeants, 25 patrol officers and detectives, special law enforcement officers and such other superior officers and patrol persons as will be determined by the township committee from time to time as being proper and feasible for the department, upon recommendation of the chief of police and the township administrator. These members of the Warren Township Police Department shall be duly sworn.

**SECTION II.** If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held invalid or unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

**SECTION III.** In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township of Warren, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Revised General Ordinances of the Township of Warren are hereby ratified and confirmed, except where inconsistent with the terms hereof.


**SECTION IV.** This Ordinance shall take effect upon adoption and final publication according to law.
