

**TOWNSHIP OF WARREN
ORDINANCE NO. 15-09**

AN ORDINANCE AUTHORIZING THE AMOUNT OF \$31,000 AS AN APPROPRIATION FROM THE CAPITAL FUND BALANCE TO PROVIDE FUNDING FOR THE PURCHASE OF A FOUR WHEEL DRIVE VEHICLE FOR USE BY THE POLICE DEPARTMENT

BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

WHEREAS, the Police Chief has requested a four wheel drive vehicle to be assigned to the Police Department in order to serve as an administrative vehicle or other support purposes; and

WHEREAS, the Township Administrator has recommended this purchase; and

WHEREAS, funds are available in the Capital Fund Balance Account No. 5-04-400-65-3800 to provide for this purchase;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey as follows:

Section 1) The capital improvement herein described below is hereby authorized as a capital improvement to be made by the Township of Warren, County of Somerset, New Jersey and for the said improvement there is hereby authorized the sum of \$31,000.

Section 2) The purpose of this appropriation is for the purchase of a four wheel drive vehicle for use by the Police Department as an administrative vehicle or other purposes as determined by the Chief with the approval of the Township Administrator.

Section 3) There is hereby authorized an appropriation from the Capital Fund Balance Account No. 5-04-400-65-3800 in the amount of \$31,000. The Township Chief Financial Officer shall, prior to the effective date of this ordinance, certifying that sufficient funds are available in the Capital Improvement Fund to make the said appropriation. The certification is incorporated within the ordinance.

Section 4) The Capital Budget of the Municipality is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith.


Section 5) Any further action regarding this project may be effectuated by resolution of the Township Committee.


Section 6) If any section or provision hereof shall be adjudged invalid, such determination shall not affect any other provisions hereof, which shall remain in full force and effect.
