

**TOWNSHIP OF WARREN
ORDINANCE NO. 16-01**

AN ORDINANCE AUTHORIZING AN APPROPRIATION IN THE AMOUNT OF \$45,000 FROM THE CAPITAL IMPROVEMENT FUND TO PROVIDE FOR THE PURCHASE OF A DUMP BODY FOR A DUMP TRUCK FOR USE BY THE PUBLIC WORKS DEPARTMENT

BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

WHEREAS, by Ordinance 15-20, the Township Committee appropriated \$140,000 for the acquisition of a dump truck cab and chassis and related equipment in the amount of \$140,000 based upon the Superintendent of Public Works' recommendation not to purchase this item but to refurbish an existing dump body for installation on the new chassis; and

WHEREAS, an evaluation of the existing dump body has revealed that the current body is beyond repair; and

WHEREAS, the Superintendent of Public Works is recommending the purchase of a new 5 to 7 cubic yard stainless steel dump body to place on the new chassis in the estimated sum of \$45,000; and

WHEREAS, it is necessary that steps be taken to provide for the establishment of the necessary financial authorization in accordance with New Jersey financial procedures to implement this project; and

WHEREAS, funds are available in the Capital Improvement Fund Account No. 6-04-225-55-3200 to provide for this purchase;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey as follows:

Section 1) The Capital equipment improvement herein described below is hereby authorized as a capital improvement to be made by the Township of Warren, County of Somerset, New Jersey and for the said improvement there is hereby authorized the sum of \$45,000.00.

Section 2) The purpose of this appropriation is for the purchase of a 5 to 7 cubic yard dump body to be installed on the new chassis for which funds have been authorized for Ordinance No. 15-20.

Section 3) There is hereby authorized an appropriation from the Capital Improvement Fund Account No. 6-04-225-55-3200 in the amount of \$45,000. The Township Chief Financial Officer shall, prior to the effective date of this ordinance, certify that sufficient funds are available in the Capital Fund to make the said appropriation. The certification is incorporated within the ordinance.

Section 4) The Capital Budget of the Municipality is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith.


Section 5) Any further action regarding this project may be effectuated by resolution of the Township Committee.

Section 6) If any section or provision hereof shall be adjudged invalid, such determination shall not affect any other provisions hereof, which shall remain in full force and effect.

Section 7) This Ordinance shall be effective upon final adoption and publication thereof in accordance with law.
