

**EXPLANATION:** This Ordinance amends Subsection 10-8.8 entitled "Permits" of *The Revised General Ordinances of the Township of Warren* to revise permit fees as required by N.J.A.C. 5:70-2.9.

**AN ORDINANCE AMENDING 10-8.8 ENTITLED "PERMITS" OF SECTION 10-8 ENTITLED "LOCAL ENFORCEMENT OF THE UNIFORM FIRE SAFETY CODE" OF CHAPTER IX ENTITLED "FIRE PREVENTION" OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WARREN**

**BE IT ORDAINED** by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey, that Subsection 10-8.8 entitled "Permits" of Section 10-8 entitled "Local Enforcement of the Uniform Fire Safety Code" of Chapter IX entitled "Fire Prevention" of *The Revised General Ordinances of the Township of Warren*, as heretofore supplemented and amended, is hereby supplemented and amended to read as follows:

**SECTION I.** Subsection 10-8.8 entitled "Permits" is hereby amended to read as follows:

10-8.8 Permits. The permit fees established by the Uniform Fire Code shall be those presently established by the State of New Jersey as follows:

Type 1-

[~~\$42.00~~] \$54.00

Type 2 –

[~~166.00~~] \$214.00

Type 3-

[~~\$331.00~~] \$427.00

Type 4 –

[~~497.00~~] \$641.00

**SECTION II.** If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

**SECTION III.** In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township of Warren, the provisions hereof shall be determined to govern. All other parts, portions and provisions of *The Revised General Ordinances of the Township of Warren* are hereby ratified and confirmed, except where inconsistent with the terms hereof.

**SECTION IV.** This Ordinance shall take effect immediately upon final passage and publication according to law.
