AN ORDINANCE OF THE TOWNSHIP OF WARREN, COUNTY OF SOMERSET, STATE OF NEW JERSEY, TO AMEND CHAPTER VII, ENTITLED “TRAFFIC” OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WARREN

BE IT ORDAINED by the Mayor and Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

SECTION 1. Subsection 7-6 entitled “Trucks Over Ten Tons Excluded” of Chapter VII entitled “Traffic” of The Revised General Ordinances of the Township of Warren is hereby amended to read as follows:

7-6 Trucks Over Ten Tons Excluded.

Trucks over ten tons registered gross vehicle weight are hereby excluded from the following described streets or parts of streets, except for the pickup or delivery of materials.

| <i>Name of Street</i> | <i>Location</i> |
|------------------------|------------------------------------------------------|
| [Ferguson Road | Entire length] |
| King George Road | From Morning Glory Road to Washing[-]ton Valley Road |
| [Morning Glory Road | Entire length] |
| Dock Watch Hollow Road | Entire length |

SECTION 2. Chapter VII entitled “Traffic” of The Revised General Ordinances of the Township of Warren is hereby amended by the addition of new Subsection 7-6.2 entitled “Trucks Over 5 Tons Excluded” to read as follows:

7-6.2 Trucks Over 5 Tons Excluded.

Trucks over 5 tons registered gross vehicle weight are hereby excluded from the following described streets or parts of streets, except for the pickup or delivery of materials:

Ferguson Road

Location
Entire length

SECTION 3. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION 4. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township of Warren, the provisions hereof shall be determined to govern. All other parts, portions and provisions of *The Revised General Ordinances of the Township of Warren* are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 5. This Ordinance shall take effect immediately upon final passage and publication according to law.
